**Pledge of Allegiance**

**Resignation of Paul Myers from Board of Auditors**

Motion Bockstoce, Second Lohr, to accept resignation of Paul Myers from Board of Auditors. Motion passed unanimously.

**Added Item – Motion to Approve Items on Agenda for Board Action**

Solicitor Liekar advised agenda posted late and motion is required to allow Board to act.

Motion Lohr, Second Kearns, to approve Board action on agenda items. Motion passed unanimously.

**Public Comment Agenda Items**

Bill Pollock stated ZHB Solicitor should be appointed by ZHB, not the Board of Supervisors, asked if 2.7 million will be transferred to CFS Bank as PLGIT is not insured, and asked about hiring of p-t manager as it was not included in budget. Chris Vanderman recommends Jim Liekar to remain as Solicitor.

**Chairman of Board of Supervisors**

Motion Bockstoce, Second Kearns, to appoint Paul Myers as Chairman of the Board of Supervisors. On a voice vote, the motion passed unanimously.

**Vice-Chairman**

Motion Bockstoce, Second Lohr, to appoint Wiltrot as Vice-Chairman of the Board of Supervisors. On a voice vote, the motion passed unanimously.

**Secretary/Treasurer**

Motion Lohr, Second Bockstoce, to appoint Julie Ann Dotson as Secretary/Treasurer and continue current treasurer's bond in effect until June 2026 at \$100,000. On a voice vote, the motion passed unanimously.

**Solicitor**

Motion Bockstoce, Second Lohr, to appoint Attorney James Liekar as Township Solicitor. On a voice vote, the motion passed. Wiltrot voted no.

**Zoning Hearing Board Solicitor**

Motion Lohr, Second Kearns, to appoint Attorney John Petrisek as Zoning Hearing Board Solicitor. On a voice vote, the motion passed unanimously.

Motion by Bockstoce, Second Kearns, to appoint Michael Luketich as Road Foreman. The motion passed unanimously.

### **Code Enforcement/Zoning Officer**

Motion Lohr, Second Bockstoce, to appoint Municipal Consulting Services as Code Enforcement/Zoning Officer. Motion passed. Wiltrot voted no.

**Building Code Official**

Motion Lohr, Second Bockstoce, to appoint Municipal Consulting Service as Building Code Official. Motion passed. Wiltrot voted no.

**Animal Control**

Motion Bockstoce, Second Lohr, to appoint Kym Secreet as Animal Control at the rate of \$450.00 per month. Motion passed. Wiltrot voted no.

**Act 511 Tax Collector**

**Washington County Sewage Council**

Motion Bockstoce, second Lohr, to appoint Julie Ann Dotson as representative to the Washington County Sewage Council. On a voice vote, the motion passed unanimously.

Motion Lohr, Second Bockstoce, to approve Township Supervisors to assist the Road Department and work in times of emergency. Motion passed. Wiltrot voted no. The Board of Auditors will be required to approve item.

Motion Bockstoce, Second Kearns, to schedule road project workshop January 28 at 1:00 p.m. On a voice vote, the motion passed unanimously.

Motion Lohr, Second Bockstoce, to set Part Time Employee wage at \$25.00 per hour. On a voice vote, the motion passed unanimously.

Motion Kearns, Second Lohr, to set the Zoning Hearing Board Members compensation at \$25.00 per hearing. On a voice vote, the motion passed unanimously.

Motion Bockstoce, second Lohr, to set the Auditors compensation at \$25.00 per meeting. On a voice vote, the motion passed unanimously.

Motion Lohr, Second Bockstoce, to set the Tax Collector's commission at 4% Discount, 5% Face. On a voice vote, the motion passed unanimously.

**Employee Benefits**

Motion Bockstoce, Second Myers, to continue the State Aid Non-Uniform Pension at 9% of gross wages. On a voice vote, the motion passed unanimously.

**Approval of Minutes**

Motion Bockstoce, Second Lohr, to approve the minutes of the December 10, 2025 meeting. The motion passed unanimously.

**Approval of Checks, Warrants & Transfers**

Motion Bockstoce, Second Lohr, to approve the payment of checks, warrants & transfers and to approve payment of invoices due prior to next scheduled meeting. On a voice vote, the motion passed unanimously.

**Public Comment Non-Agenda Items**

Barb Campbell asked who to call for downed trees and stated that there are several tri-axle trucks on her neighbor's property she would like addressed.

Kathy Kennedy asked Board to appoint Paul and Stephanie to Recreation Board as they already have their letters of interest.

Bill Pollock asked for minutes to be read at meeting to allow him to make corrections, asked for budget to be in QuickBooks, and asked about water projects. He said wells are contaminated with arsenic. He also asked for road bonds to be reviewed, inquired about massage parlor, and gambling halls.

Mike Ornot asked for actual credit card charges to be available for view and stated that residents should be informed of promotions a month before the meeting.

Paul Myers stated that he will hold office hours to allow residents to meet and discuss Township concerns on the following dates: first and third Wednesday from 5-7pm and second and fourth Wednesday from 10am-Noon.
